He acknowledged that because of the type of crime and the email circulating throughout the community the children at the schools and using the Town's facilities have become affected by the incident. The Mayor advised that he would like to personally send a letter on behalf of Council to Children's Services and the Minister of Justice requesting a thorough investigation and to accept any recommendations given to help the kids move forward so that there are no problems in the future.
- Discussion was held in regards to that the Town was not legally in the loop because it involved minors, and they had expressed concern about how the community can move forward from this.
- Council agreed with the Mayor to send a letter of concern to the Minister of Justice and Children's Services.


