**13. QUESTIONS/CONCERNS FORUM WITH PUBLIC AND PRESS:**

Mike Gordon expressed concerns that the industrial park in south west Calmar was still not completed, there are no lights, no roads, and asked when will this be completed. He cannot develop his property until this subdivision is complete.

Shane Anderson also expressed concerns over the uncompleted industrial subdivision, stating he did sign a letter of understanding with the Town that he could develop his property with the understanding that the subdivision was not completed, and that the Town would not hold responsibility, but asked when would the Town be forcing the subdivision to be completed. He was concerned because the Town at the time of the subdivision application was made, did not take a security deposit, no engineered designs and a no deadline was given. A reasonable amount of time has passed, and Mr. Anderson requested that legal action be taken.

Mayor Faulkner empathized with the concerns, and explained that the subject would be discussed during the in camera session at this meeting, and that Council had every desire to ensure that this subdivision is completed in a timely manner.

Mike Gordon also expressed concerns that the asphalt in the driveway of his acreage just off Westview Drive had been damaged by the previous construction in area and trucks turning around on his property and that the gravel on his driveway need to be replaced. He went on to inquire if the stairway/roof access to the Medical/Dental clinic had been blocked to keep children off it.

Director of Planning & Development Melesko advised that the asphalt would be repaired as soon as the guardrail was replaced and that the gravel inside the fence would be a private matter between Mr. Gordon and Crow Enterprises.

Town Manger Murphy advised that Director of Community Services Bachman would contact Mr. Gordon in regards to the Medical/Dental clinic roof access.

Mark Wierzbicki of the Devon Dispatch inquired if the Assessment Open House was held every year.

Mayor Faulkner advised that it was held every year.

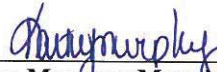
