Mike also explained that 93.1FM's community cruiser will be on the road covering community events throughout the region including the Leduc Music festival, Canada Day Events, Beaumont Town and Country Daze, Strawberry festival, Festival of Trees, Calmar and Devon Days and much more. 93.1FM should be up and running in a couple weeks.


