She explained that it is a multi-municipal program, agreements with Calmar, Thorsby, and Warburg, and regional offices in Calmar, New Sarepta, Thorsby, and Warburg. FCSS provides; Community Support, Family Support, Senior Services, Counselling, Administration of FCSS, as well as regional programs; Bridges FASD Mentor Program, Early Childhood Resource Program, Family Connections, and Parent Link. She explained that there are no boundaries in a multi-municipal program, meaning equal service to all residents. Ms. Hourihan explained the funding of the program from each municipality, the Province, and Leduc County.
